## FEEDBACK REGARDING SUBSTITUTE EXPERIENCE

Thank you all for your feedback. This was a very interesting survey in terms of the data we received. We thought the information was so helpful that we have included a report. We anticipate being able to review this information with suggested strategies to address your areas of concerns, training desires, and suggestions for strategies related to substitutes in many issues of HR Connections to come.

## FEEDBACK FROM SUBSTITUTES

We asked substitutes for feedback....here is what we learned:

- 75% of participating substitutes worked so that they would earn the Temporary Substitute Incentive Bonus last year.
- 84.8% of participating substitutes find information about substituting with Jordan in Frontline!
- 10% of our substitutes actively substitute in another District in addition to Jordan.
- Top two reasons a location became their favorite were 1) Friendly Staff and 2) Close to Home.
- 62% of participating substitutes have subbed with Jordan for less than 3 years. CONGRATULATIONS TO OUR TOP TEN FAVORITE LOCATIONS TO SUB!
